Instruction:

1. Click on "Log In" in the top right corner.
2. Click on "Trip" from top menu.
3. To add new trip, click on a "Add New Trip" button
4. For "Date Traveled," enter the pickup date.
5. For "Truck" choose the truck you want to report. The Truck ID, Truck Name, Registered Company, and Registered IRP will automatically pre-fill.
6. "Odometer Start" and "Odometer End" is optional.
6. For "Stops," enter the zip codes where the driver travels. (Ignore slots #6 & #7. They do not work.)
 - + Stop 1: put the zip code where driver picked up the load.
 - + Stop 5: put the zip code where driver delivered the load.
 - + Stops 2-4: put the zip code where driver puts fuel; or important turn points, for example: Knoxville, TN or Allentown, PA.
7. Click on "Calculate Routes" button. Scroll down and you will see the route the driver runs. If it displays more than 1 possible route, choose the right route.
8. Under "Enter Trip Details per State," enter in the gallons, using the fuel receipts. State and Miles In State will

automatically pre-fill after choosing the route.

9. Click "Save" button when you are done.
